Learning Support Coordinator is in charge of the confidential documents. The coordinator send the document to the prospective's counselor or special care coordinator directly.

If requested by the school and authorized by the parents, we will send this documentation

There has been no request.

These are only sent when requested by a school and sent directly to the person that asks for them from that school

We don't send anything as a rule, but will mention them on a reference form from the new school or if a school contacts us. We suggest that they ask parents for the documents.

In our model, these evaluations are completed by outside providers and are paid for by parents - as such they are the property of families. We would clarify to new schools when evaluations have been completed (this is part of qualifying for learning support services) and suggest to parents that they share such evaluations with new schools.

Learning Support staff deal with that and if requested by schools etc I pass onto the relevant Counsellor

If any of documents are evaluated, the result may send with IEP.

If authorized by the parents, we send it

We encourage the parents to send directly to prospective school so they can find the right fit school for their child.


These are only sent when requested by a school and sent directly to the person that asks for them from that school

Parents must have signed an agreement with the new school to release all records	
We have a release form which we sometimes ask parents to complete so that we can receive information directly from a tester, therapist, etc. This applies mainly to current students. There are questions on our application form about ed psych, speech, etc evaluations and IEPs. If parents answer 'yes' to any of these they are required to provide a copy of the document as a condition of admission. There is a statement that failure to disclose information could lead to admission decisions being reversed or continued enrolment could be in question.
