In the JIS High School Profile sent to universities/colleges at the time of application, it states that "JIS students are limited to ten (10)

				applications globally” and that “an application from a JIS student is a well-considered one”. Examples of application systems which count as one application are as follows: the University of California system application, the UCAS application for the UK, and OUAC for Ontario, Canada. However, in the Common Application system used for many universities in the US, each university/college is counted individually. Students and parents are encouraged to speak with their counselor for further clarification.
